#### **VET NOTES** Sharon Hoofnagle D.V.M. Head nod on the Trail

The walk is a four-beat gait that averages 4 mph. It is the most common gait used with the mountain horse. At a walk a horse moves its head and neck in a slight up and down motion in time with the leg movement. This is called a "head nod" and it has been thought that it helps maintain balance

However a recent study in Europe brought up an interesting factor. They found that a walk it is more energy efficient if the horse can nod his head, and that walking for an extended period of time is more tiring if head movement is restricted.

(Timing of head movements is consistent with energy minimization in walking ungulates," was published in the Proceedings of the Royal Society B: Biological Sciences.)

I won't go into the mechanics of the article-it talks about things like inverted pendulums for example, but it's an interesting study.

So how does this apply to the trail horse? Here are some of my thoughts.

COORDINATOR Roger Nelson One instance that can restrict the head nod is continuous collection, or excess rein pressure 360-599-2461 The use of collection where the neck is flexed vs. a loose rein where the head and neck are extended are mostly related to what the horse is doing and most riders switch back and

forth. We collect the horse when we want to direct the horse more precisely on the trail. But most of the time we let the horse have a loose rein and the head nod can occur

.However some horses have a lot of "motor", and need constant rein pressure to slow them down. This can restrict the "nod". Some fuss with the bit with the same result.

There might be a mismatch between a ridden horse and a pack horse, where the rider has to hold constant pressure on the lead rope of the pack horse. That could prevent the head nod

.A lameness will interfere with the amplitude of the head nod

These could be issues on longer rides. Horses often tire. We know there are sometimes issues with sleep deprivation, lack of conditioning, and sometimes lack of feed. Our horses need all the help we can give them. Restricting head movement might be another factor to consider avoiding..

Cindy sent their club a thank you card for the donation.







